
Stoffenmanager® implementation steps

# Data entry: entering product data from Safety Data Sheets

Entering information from Safety Data Sheets (SDSs) is a time-consuming activity and requires the necessary knowledge. Do you want your data entry and management carried out for you? That is possible! You deliver the SDSs and we will enter all the necessary data for you, such as physical-chemical, ATEX, PGS-15 and workplace instruction card data, after which you can link the products to your location. We will then create components for you and complete missing information, such as vapor pressure or public limit values. This gives you a complete register of hazardous products and a specific register of all your carcinogenic, mutagenic and reprotoxic (CMR) products.

### Updating products and components register

Do you want your components to always be up-to-date so that you no longer have to worry about it? We will gladly perform an annual check of whether the limit values of your components are still up-to-date. We can also maintain your products. We update your product database based on a 3-year cycle. It is important to know that you always remain the owner of your data and not Stoffenmanager®. This means that the data is easy to import and export.

#### What are the options?

- Once every 3 months you deliver new products that we enter into Stoffenmanager®.
- Once every 3 months you provide a new SDS for your products that are more than 3 years old. We make sure that your old products are updated.
- Once a year we update all the limit values of your components.

#### Risk assessment of hazardous substances

The core expertise of Stoffenmanager® is performing quantitative hazardous substances assessments. Would you rather have this assessment performed for you? Then we will start with mapping workplace scenarios and data processing in Stoffenmanager® together. We will analyse whether your workplace is sufficiently controlled or whether additional control measures or other follow-up steps are necessary. Then we will set up a strategy for performing exposure assessments so that they can be carried out effectively.

### Applying the STOP strategy

Applying the STOP strategy, also referred to as the occupational hygiene strategy, is an important step in controlling risks. Based on outcomes from Stoffenmanager® or the measurement results, we can advise you on taking the right measures. We can also support you in preparing and testing a plan of action.

#### Measurement of hazardous substances

If the risk assessment by Stoffenmanager® shows that the situation is not fully controlled, one of the next steps is to perform measurements. These include exposure measurements for different types of dangerous substances such as: liquids, powders, and solvents. Measurements may also be necessary for substances that cannot be assessed by Stoffenmanager®, such as welding fumes, diesel engine emissions, combustion processes and nanoparticles. We set up a suitable measurement strategy, carry out the measurements and test them against the current standard. You will receive a report with findings and recommendations for your organisation.

#### **Biological monitoring**

Biological monitoring is used to assess the total exposure to substances or, for example, to demonstrate the effectiveness of personal protective equipment. It can be used to determine whether employees are adequately protected when they perform their work. Think of solvents, isocyanates or metals. We advise you on the options for using biological monitoring within your organisation.
